

## *“Informing on Personal Data*

*This text aims to inform the real person customers that Johnson & Johnson Consumer Products Group of Johnson and Johnson Sihhi Malzeme San. ve Tic. Ltd. (“Johnson & Johnson”) will use their personal information in accordance with the Code on Protection of Personal Data #6698 and to raise their awareness on their rights under the said Code.*

*Johnson & Johnson will process personal data of its real person customers only upon their express consent as a general rule. Nevertheless, if it is necessary to execute an agreement with our company and the real person customers and to fulfill our liabilities arising thereof, personal data such as identity details, address and contact details will be process in accordance with the subparagraph (c) of subsection 2 of article 5 of the said Code.*

*Johnson & Johnson might share the personal data of real person customers with Johnson & Johnson group companies or business partners inside or outside the country if it is required to do so to fulfill its liabilities arising from the agreements executed between the company and the real person customers.*

*In case our real person customers contact our company to get information on our products or services or to convey their complaints, personal data of our customers will be processed in accordance with the subparagraph (f) of subsection 2 of article 5 of the said Code solely to improve the quality of the relevant products and services and to better serve our customers. Those real person customers who are unwilling to allow their personal data to be process for the above described purposes, might contact the addresses indicated in this text and communicate their request. The processing of the personal data of customers who have made such a request will be stopped immediately, personal data already processed until the time of the request will be deleted or made anonymous.*

*If required by the laws or any legislation of the Republic of Turkey or if it is mandatory to do so for Johnson & Johnson to fulfill its legal liabilities and particularly if requested by the authorized public agencies, personal data will be processed in accordance with the Code on Protection of Personal Data and shared with relevant persons and agencies when necessary.*

*Personal data kept by Johnson & Johnson will be stored throughout the legal period allowed by the legislation and as long as it is required in terms of the aim of their collection. At the end of such period, the data will be deleted or made anonymous upon your request or ex officio as per article 7 of the Code on Protection of Personal Data.*

*This informative text serves as a general explanation on the activities of Johnson & Johnson and personal data owners may contact our company for detailed information if they wish to do so.*

*All our real person customers will have the following rights under the Code on Protection Personal Data:*

- *finding out if their personal data is processed,*
- *demanding information on any processed personal data,*
- *finding out the purpose of processing of such personal data and whether those are used in line with their purposes,*
- *knowing the third persons to whom the data is transferred inside and outside the country,*
- *requesting the correction of any deficient or erroneous personal data,*
- *requesting the destruction or deletion of personal data under article 7 of the Code on Protection of Personal Data,*
- *asking that the correction or deletion requests are communicated to third parties that possess the personal data,*
- *objecting any outcome that is unfavorable to the person by analyzing the processed data exclusively through automatic systems,*
- *requesting a compensation for damages caused by unlawful processing of personal data.*
